2. I am aware of the risk, hazards and danger of personal injury, disability and/or death as a result of participation at KidzPlay.
3. In consideration for the admission of my child, I hereby release, waive and forever discharge and covenant not to sue Hardin Express Inc. d/b/a KidzPlay or Hardin Rentals and its owners, agents, employees, directors, officers, trustees and all other persons or entities acting on its behalf, from any and all claims, actions, damages, liability, cost or expense including attorneys fees which are related to or arise out of or in any way connected to my child's participation or use of the facility.

By the execution of this agreement, it is my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against Hardin Express Inc. d/b/a KidzPlay or Hardin Rentals, its owners employees, agents, officers, directors and/or all other persons or entities acting on its behalf.
5. I acknowledge that my child's or minor's participation in activities at KidzPlay is strictly voluntary.
